SECTION 4: First aid measures

Description of first aid measures

First-aid measures general

: In case of spontaneous vomiting, transport the victim to a hospital, to verify the possibility that the product has been aspired into the lungs.

First-aid measures after inhalation

: In case of disturbances owing to inhalation of vapours or mists, remove the victim from exposure; keep at rest; if necessary, seek medical attention. See also Point

First-aid measures after skin contact

Take off contaminated clothing and shoes. Wash thoroughly with soap and water. If inflammation or irritation persists, seek medical advice. 4.2. Most important symptoms and effects, both acute and delayed

SECTION 5: Firefighting measures

Extinguishing media 5.1.

Suitable extinguishing media

: Small-size fires: carbon dioxide, dry chemicals, foam, sand or earth. Large fires: foam or water fog (mist). These means should be used by trained personnel only. Other extinguishing gases (according to regulations).

6.3. Methods and material for containment and cleaning up

For containment

: Contain spilled liquid with sand, earth or other suitable absorbents (non-flammable). Recover free liquid and waste materials in suitable waterproof and oil-resistant containers. Clean contaminated area. Dispose of according to local regulations. If in water: Confine the spillage. Remove from surface by skimming or suitable floating absorbents. 7.1. Precautions for safe handling

Precautions for safe handling
