2.3. Other hazards (not relevant for classification)

Other hazards not contributing to the classification

: This product is combustible, but not classified as Flammable. The creation of flammable vapour mixtures takes place at temperatures which are higher than normal ambient levels. In case of contact with eyes, this product may cause irritation. If the product is handled or used at high temperature, contact with hot product or vapours may cause burns. Any substance, in case of accidents involving pressurized circuits and the like, may be accidentally injected under the skin, even without external damage. In such a case, the victim should be brought to an hospital as soon as possible, to get specialized medical treatment. Do not wait for symptoms to develop. In exceptional cases (i.e prolunged storage in tanks contaminated with water, and presence of anaerobic sulfate-reducing microbial colonies), the product may undergo a degradation and generate small amounts of sulfur compounds, including H2S.

First-aid measures after skin contact

: Take off contaminated clothing and shoes. Wash thoroughly with soap and water. If skin irritation occurs: Get medical advice/attention. In case of contact with hot product, cool affected part with plenty of cold water, and cover with gauze or clean cloth. Call a doctor or bring to an hospital. Do not use salves or ointments, unless directed by doctor. Body hypothermia must be avoided. Do not put ice on the burn.

First-aid measures after eye contact

Rinse eyes thoroughly for at least 15 minutes. Keep eyelids well apart. Remove contact lenses, if present and easy to do. Continue rinsing. If irritation, blurred vision or swelling occurs and persists, obtain medical advice from a specialist. In case of contact with hot product, cool affected part with plenty of cold water, and cover with gauze or clean cloth. Call a doctor or bring to an hospital. Do not use salves or ointments, unless directed by doctor.

First-aid measures after ingestion

Do NOT induce vomiting. If the person is conscious, rinse mouth with water without swallowing. Keep at rest. Call for medical assistance or bring to an hospital. If the casualty is unconscious, place in the recovery position. In case of spontaneous vomiting, keep head low, to avoid the risk of aspiration into the lungs. Do not give anything by mouth to an unconscious person.

4.2. Most important symptoms and effects, both acute and delayed

Symptoms/effects after inhalation

: This product has a low vapour pressure, and in normal conditions at ambient temperature the concentration in the air is negligible. A significant concentration may build up only if the product is used at high temperature, or in case of sprays and mists. In these cases overexposure to vapours may cause irritation to airways, nausea and dizziness.

Symptoms/effects after skin contact Symptoms/effects after eye contact

: Contact with hot product may cause thermal burns.

: Contact with eyes may cause temporary reddening and irritation. Contact with hot product or vapours may cause burns.

Symptoms/effects after ingestion

: Accidental ingestion of small quantities of the product may cause nausea, discomfort and gastric disturbances.

Symptoms/effects upon intravenous administration

: No information available.

Chronic symptoms

: None known.

4.3. Indication of any immediate medical attention and special treatment needed

Obtain medical attention if casualty has an altered state of consciousness or if symptoms do not resolve. Seek medical attention in all cases of serious burns. If there is any suspicion of inhalation of H2S (hydrogen sulphide), Rescuers must wear breathing apparatus, belt and safety rope, and follow rescue procedures. Send patient to hospital. Immediately begin artificial respiration if breathing has ceased. Administer oxygen if necessary.

SECTION 5: Firefighting measures

5.1. Extinguishing media

Suitable extinguishing media

: Small-size fires: carbon dioxide, dry chemicals, foam, sand or earth. Large fires: foam or water fog (mist). These means should be used by trained personnel only. Other extinguishing gases (according to regulations).

Unsuitable extinguishing media

: Do not use water jets. They could cause splattering, and spread the fire. Simultaneous use of foam and water on the same surface is to be avoided as water destroys the foam.

5.2. Special hazards arising from the substance or mixture

Fire hazard

: This product is combustible, but not classified as Flammable. The creation of flammable vapour mixtures takes place at temperatures which are higher than normal ambient levels.

Explosion hazard

: In case of losses from pressurized circuits, the sprays may form mists. Take into account that in this case the lower explosion limit for mists is about 45 g/m3 of air.

Hazardous decomposition products in case of fire

: Incomplete combustion is likely to give rise to a complex mixture of airborne solid and liquid particulates, gases, including carbon monoxide, NOx, H2S and SOx (harmful/toxic gases). Oxygenated compounds (aldehydes, etc.).

5.3. Advice for firefighters

Firefighting instructions

: Shut off source of product, if possible. Move undamaged containers from immediate hazard area if it can be done safely. Spilled product which is not burning should be covered with sand or foam. Use water sprays to cool containers and surfaces exposed to the flames. If the fire cannot be controlled, evacuate area.

SECTION 6: Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

General measures

: Stop or contain leak at the source, if safe to do so. Eliminate all ignition sources if safe to do so (e.g. electricity, sparks, fires, flares). Avoid accidental sprays on hot surfaces or electrical contacts. Avoid direct contact with released material. Keep upwind.

6.1.1. For non-emergency personnel

Protective equipment Emergency procedures : See Section 8.

Keep non-involved personnel away from the area of spillage. Alert emergency personnel. Except in case of small spillages, the feasibility of any actions should always be assessed and advised, if possible, by a trained, competent person in charge of managing the emergency.

6.1.2. For emergency responders

Protective equipment

: Small spillages: normal antistatic working clothes are usually adequate. Large spillages: full body suit of chemically resistant and antistatic material. if necessary heat resistant and insulated. Work gloves providing adequate chemical resistance, specifically to aromatic hydrocarbons. Gloves made of PVA are not water-resistant, and are not suitable for emergency use. If contact with hot product is possible or anticipated, gloves should be heat-resistant and thermally insulated. Antistatic non-skid safety shoes or boots, chemical resistant, if necessary heat resistant and insulated. Work helmet. Goggles and /or face shield, if splashes or contact with eyes is possible or anticipated. Respiratory protection: A half or full-face respirator with filter(s) for organic vapours (A) (or A+B when applicable for H2S), or a Self-contained Breathing Apparatus (SCBA) can be used according to the extent of spill and predictable amount of exposure. If the situation cannot be completely assessed, or if an oxygen deficiency is possible, only SCBA's should be used.

Emergency procedures

: Notify local authorities according to relevant regulations.

6.2. Environmental precautions

Do not let the product accumulate in confined or underground spaces. Do not let the product flow into sewers or water courses, or in any way contaminate the environment. In case of contamination of environment compartments (soil, subsoil, surface or underground waters), remove contaminated soil when possible, and in any case treat all involved compartments in accordance with local regulations. The site should have a spill plan to ensure that adequate safeguards are in place to minimize the impact of episodic releases.

6.3. Methods and material for containment and cleaning up

For containment

: Contain spilled liquid with sand, earth or other suitable absorbents (non-flammable). Recover free liquid and waste materials in suitable waterproof and oil-resistant containers. Clean contaminated area. Dispose of according to local regulations. If in water: Confine the spillage. Remove from surface by skimming or suitable floating absorbents. Collect recovered product and other waste materials in suitable waterproof, oil resistant containers. Recover or dispose of according to local regulations. Do not use solvents or dispersants, unless specifically advised by an expert, and, if required, approved by local authorities.

Other information

: Recommended measures are based on the most likely spillage scenarios for this material; however, local conditions (wind, air/water temperature, wave/current direction and speed) may significantly influence the choice of appropriate actions. SECTION 7: Handling and storage

7.1. Precautions for safe handling

Precautions for safe handling

: This material is combustible, but will not ignite readily. Provide adequate ventilation. Use adequate personal protective equipment as needed. Due to the extremely slippery nature of this material, more care than usual must be exercised in material handling practices to keep off all walking surfaces. Floors, walls and other surfaces in the hazard area must be cleaned regularly. Avoid release to the environment. Emptied containers can contain combustible product residues. Do not cut, weld, drill, burn or incinerate empty containers or drums, unless they have been drained and cleaned. The product may release Hydrogen Sulphide: a specific assessment of inhalation risks from the presence of hydrogen sulphide in tank headspaces, confined spaces, product residue, tank waste and waste water, and unintentional releases should be made to help determine controls appropriate to local circumstances. Note

: The Derived No Effect Level (DNEL) is an estimated safe level of exposure that is derived from toxicity data in accord with specific guidance within the European REACH regulation. The DNEL may differ from an Occupational Exposure Limit (OEL) for the same chemical. 8.2.2.1. Eye and face protection

Eye protection:

When there is a risk of contact with the eyes, use safety goggles or other means of protection (face shield). If necessary, refer to national standards or to the EN 166 standard.

8.2.2.2. Skin protection

Skin and body protection:

Long-sleeved overalls. If necessary, refer to the EN 340 and related standards, for definition of characteristics and performance according to the risk rating of the area. Antistatic non-skid safety shoes or boots, chemical resistant, if necessary heat resistant and insulated.

Hand protection:

Respiratory protection:

Independently from other possible actions (technical modifications, operating procedures, and other means to limit the exposure of workers), personal protection equipment can be used according to necessity. Approved respiratory protection equipment shall be used in spaces where hydrogen sulphide may accumulate: full face mask with cartridge/filter type "B" (grey for inorganic vapours including H2S) or self-contained breathing apparatus (SCBA). (EN 136/140/145)

8.2.3. Environmental exposure controls

Environmental exposure controls:

Do not discharge the product into the environment. Storage areas/installations should be designed with adequate bunds so as to prevent ground and water pollution in case of leaks or spills. Prevent discharge of undissolved substance to or recover from onsite wastewater. Onsite wastewater treatment required. Do not apply industrial sludge to natural soils. This situation is especially relevant in all those circumstances which require to enter a confined space, with direct exposure to the vapours. If this possibility is suspected, a specific assessment of inhalation risks from the presence of H2S in confined spaces must be made, to help determine prevention measures and controls (i.e. PPE) appropriate to local circumstances, and adequate emergency procedures. If there is any suspicion of inhalation of H2S (hydrogen sulphide), Rescuers must wear breathing apparatus, belt and safety rope, and follow rescue procedures. Send patient to hospital. Immediately begin artificial respiration if breathing has ceased. Administer oxygen if necessary. This situation is especially relevant for those operations which involve direct exposure to the vapours in the interior of tanks or other confined spaces. Therefore, it is very important to follow the above mentioned precautionary measures also with used oils.
